## The Fridtjof Nansen Institute (FNI)

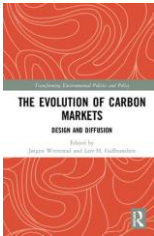
researches international climate politics at various levels, from the global level down to sub-national initiatives.

FNI has been a long-time observer and analyst of international climate negotiations within the UN Climate Convention (UNFCCC). In cooperation with leading international research institutes, FNI is researching the climate policies of key global actors such as the EU, USA, China and Russia, regarding both domestic policy formulation and implementation and the role of these actors in international negotiations.

Norwegian climate policy is also a natural focal point of research.

FNI furthermore conducts studies into various aspects of energy policy, much of it closely related to climate policy.

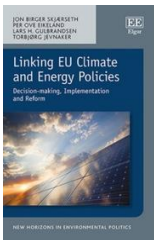

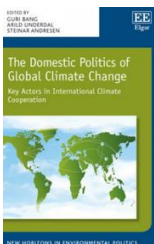

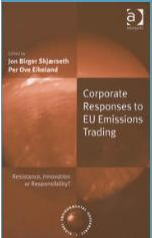
